This fund is being established to memorialize Mrs. Elizabeth Harris Lewis, by all of her children. Southern Illinois University has been a major factor in the lives of the Lewis family and all of them were culturally enriched by having lived in the Southern Illinois University community. At least one scholarship may be awarded to a current SIUC student with junior standing for semester scholarship is awarded, or a transfer student from John A. Logan College based on criteria and need. Scholarships may not be awarded at times when there are no qualified candidates.

CRITERIA for the ELIZABETH LEWIS MEMORIAL SCHOLARSHIP

- Complete and return attached application.
- Submit current transcripts from all colleges attended.
- Based on academic achievement with a minimum 3.0 GPA as calculated by SIUC Office of Admissions and financial need.
- Be a graduate of an accredited Jackson County high school.
- A current SIUC student with junior standing (for semester scholarship is awarded) or a transfer student from John A. Logan College with junior standing at SIUC (for semester scholarship is awarded.)
- Two letters of recommendation written by individuals who can speak to one's moral and intellectual stability.
- A copy of one's student aid award letter.
- Preference will be given to an applicant with a parent, sibling, aunt, uncle or grandparent who is a member of the SIU Alumni Association.
- Individuals related to the Board of Directors, full time staff of the SIU Alumni Association and/or the SIU Foundation are ineligible for consideration of the Elizabeth Lewis Memorial Scholarship.
- Financial need will be determined by selection committee. Additional information regarding financial need is welcome with your application.

The student who is awarded this scholarship will be entitled to this scholarship (amount awarded may vary) for two consecutive years provided the student remains in good standing at SIUC. The award amount will be credited to the recipient's SIUC Bursar account (½ fall semester; ½ spring semester). Any balance due will reflect a credit for the amount of this scholarship. Failure to be enrolled for the entire academic year, both fall and spring semester, will result in revocation of the scholarship award. All applications will be reviewed by the Jackson County Scholarship Committee.

All application materials must be submitted (not postmarked or FAXed) to the SIU Alumni Association office prior to 4:30 p.m., Friday, March 5, 2010. All applicants will be notified by mail of their application status. Each recipient will be invited to and recognized at the annual Jackson County Awards Banquet to be held in November. All recipients are expected to attend these events.
