### **2010-2011 Scholarship Application**

Funded by annual contributions and the endowment created by Jackson County SIU alumni, these scholarships are awarded annually to deserving high school seniors who will be attending Southern Illinois University Carbondale (SIUC) upon graduation from high school. At least one scholarship may be awarded to a graduating senior from each accredited high school in Jackson County based on scholarship and need. Scholarships may not be awarded at times when there are no qualified candidates.

#### **CRITERIA for the JACKSON COUNTY HIGH SCHOOL SCHOLARSHIP**

- complete and return attached application
- submit a current/official high school transcript
- attach a brief summary (limit to one page) of your high school, community service, and other related activities over the last 4 years
- based on academic achievement with a B or better GPA and financial need
- be a graduate of an accredited Jackson County high school
- be a resident of Jackson County
- be an admitted or registered, full-time student at SIUC, for Fall 2010

The scholarship award amounts vary from year-to-year, based on contributions received from local alumni donors. The award amount will be credited to the recipient's SIUC Bursar account (½ fall semester; ½ spring semester). Any balance due will reflect a credit for the amount of this scholarship. Failure to be enrolled for the entire academic year, both fall and spring semesters, will result in revocation of the scholarship award. All applications will be reviewed by the Jackson County Scholarship Committee.

**All application materials must be submitted (not postmarked or FAXed) to the SIU Alumni Association office prior to 4:30 p.m., Friday, March 5, 2010.** All applicants will be notified by mail of their application status. Presentation of the scholarship may occur at the recipient's annual honors day program. Each recipient will be invited to and recognized at the annual Jackson County Awards Banquet to be held in November. All recipients are expected to attend these events.
