2008-2009 Scholarship Application

Funded by an annual contribution from Nancy Baker Vallino, this scholarship is awarded annually to a deserving high school senior who will be attending Southern Illinois University Carbondale (SIUC) upon graduation from high school. Scholarships may be awarded to a graduating senior from Pinckneyville Community High School in Perry County (PCHS) based on scholarship and need. Scholarships may not be awarded at times when there are no qualified candidates.

CRITERIA for the BAKER FAMILY PCHS SCHOLARSHIP

- ! complete and return attached application
- ! submit a current/official high school transcript
- ! attach a brief summary (limit to one page) of your high school, community service, and other related activities over the last 4 years
- ! based on academic achievement with a B or better GPA and financial need
- ! be a graduate of Pinckneyville Community High School
- ! be a resident of Perry County
- ! be an admitted or registered, full-time student at SIUC, for Fall 2008

One scholarship will be awarded for the 2008-2009 academic year, totaling \$1,000. The award amount will be credited to the recipients' SIUC Bursar account (½ fall semester; ½ spring semester). Any balance due will reflect a credit for the amount of this scholarship. Failure to be enrolled for the entire academic year, both fall and spring semesters, will result in revocation of the scholarship award. All applications will be reviewed by the Perry County Scholarship Committee.

All application materials must arrive (not postmarked or FAXed) in the SIU Alumni Association office prior to 4:30 p.m., Friday, March 14, 2008. All applicants will be notified by mail of their application status. Presentation of the scholarship may occur at the recipient's honors day program or at an awards banquet.
