2012-2013 Scholarship Application

Funded by annual contributions of Perry County SIU alumni, these scholarships are awarded annually to deserving high school seniors who will be attending Southern Illinois University Carbondale (SIUC) upon graduation from high school. Scholarships may be awarded to a graduating senior from an accredited high school in Perry County based on scholarship and need. Scholarships may not be awarded at times when there are no qualified candidates.

CRITERIA for the PERRY COUNTY HIGH SCHOOL SCHOLARSHIP

- complete and return attached application
- submit a current/official high school transcript
- attach a brief summary (limit to one page) of your high school, community service, and other related activities over the last 4 years
- based on academic achievement with a B or better GPA and financial need
- be a graduate of an accredited Perry County high school
- be a resident of Perry County
- be an admitted or registered full-time student at SIUC for Fall 2012

The scholarship award amounts vary from year-to-year based on contributions received from local alumni donors. The award amount will be credited to the recipient's SIUC Bursar account (½ fall semester; ½ spring semester). Any balance due will reflect a credit for the amount of this scholarship. Failure to be enrolled for the entire academic year, both fall and spring semesters, will result in revocation of the scholarship award. All applications will be reviewed by the Perry County Scholarship Committee.

All application materials must be submitted (not postmarked or faxed) to the SIU Alumni Association office prior to 4:30 p.m., Friday, March 2, 2012. All applicants will be notified by mail of their application status. Presentation of the scholarship may occur at the recipient's honors day program or at an awards banquet. All recipients are expected to attend these events.
